



We launch an international residency program for architects in Brussels  
**Architecture Curating Practice**

The residency program organised by Architecture Curating Practice is a five-month residency offered twice a year to young or established architects. The main ambition of the residency is to offer a purposeful long-term support to architects to develop a meaningful research and production of their interest related to the architecture discipline. The projects should be experimental and composed of two distinctive parts: a documented research on the proposed subject and a physical production that could take various aspects and forms including, amongst others, objects, installations, sculptures, texts, video works, models, ...

The program is accompanied by at least two public events — debates, lectures, round tables, discussions, ... — relating to the developed topic to serve and nourish the work of the resident. At the end of the residency the produced work is to be presented to the public in an exhibition running from one day to several weeks. All these events will be curated and organised in collaboration with Architecture Curating Practice and will take place in their exhibition space *et al.*

Emphasis is placed on the location of the (exhibition and working) space in Brussels but also on the relations that can be created with the Belgian context. Brussels is bursting! It is one of the most interesting scenes for (emerging) artists and architects and therefore an enriching environment to work in. During the whole residency,

a working space is made available in the exhibition space runned by Architecture Curating Practice. *et al.* is located in the Marolles neighborhood in the city centre of Brussels.

The residents are expected to work independently and to be concerned with architecture. They should have a critical point of view on the current state and trends of the discipline. There is no obligation to stay in Brussels during the time of the residency but participants are encouraged to attend to the cultural activities in Brussels and Belgium.

Residencies run from September through January, and from February through June. Every residency ends with the presentation of the completed work in an exhibition organised in the exhibition space *et al.* Documentation of the research and the exhibition will then permanently be shown on the website of Architecture Curating Practice. Produced works will be kept and stored at *et al.* and become part of it's collection.

A jury, composed by the founding members of Architecture Curating Practice and external guests, will select the winning application from the submissions received. They will also be accompanying the resident during the entire process by giving feedback on the work and facilitate access and contact with the Belgian network.

This residency program is funded by the Flemish Government in cooperation with Architecture Curating Practice and organised at *et al.*

### **Application Deadline**

22 June 2023 CET (Brussels)

### **Application Criteria**

- The applicant must be a graduate architect, including architects who have just graduated
- The exploration project must talk about architecture in a contemporary and critical way
- The project must include two aspects: research and production
- The research and production must be presented in an exhibition opening in February 2024

The residency is also open to teams or architecture offices. For each team a contact responsible needs to be named and transmitted in the application.

A presence in Brussels is not mandatory during the residency. The resident must be present in Brussels at least four times during the process, for the three presentation moments (every six weeks) that can be linked to the complementary events/discus-

sions and for the set up and opening of the exhibition.

### **Application Materials**

Applications for the Architects in Residence program of Architecture Curating Practice should include up to four A4 pages with the following information:

- Curriculum Vitae including contact data (name, address, phone number, e-mail) and nationality (1 page)
- Reference works that can be realized or projected (1 page)

We ask you to select the most representative works showing your distinctive (experimental) approach to architecture.

- Project description including the ambitions and objectives (2 pages max.).

The project must include research and production.

### **Duration**

1 September 2023 – 31 January 2024

Punctuated by two complementary events/discussions and three official (internal) presentation moments. At the end of the residency, the exhibition will be opening in February 2024.

### **Additional requirements**

Three presentation moments — every six weeks — will be foreseen with the accompanying board of Architecture Curating Practice to follow up and give feedback on the research and production.

At least two complementary events/discussions will be organized at *et al.* in collaboration with Architecture Curating Practice. These will serve as presentation and discussion moment focusing on the work in progress.

The result of the research and production will have to be presented in an exhibition running from one day to several weeks opening in February 2024 at the Brussels based exhibition space *et al.* The exhibition will be curated and realized in collaboration with Architecture Curating Practice.

The resident(s) should be able to work independently and have a critical point of view on the current state and trends in the architecture discipline.

## **Budget**

A budget of € 2.000/month will be allowed to the resident/team. In addition, a production budget of € 5.000 will be available for the exhibition at *et al.*

All extra costs will have to be paid from the allowed budget. For the whole duration of the residency a working space will be available in the exhibition space *et al.* located in the Marolles in the city center of Brussels.

## **Awarding of Residencies**

The selection will be made by a jury composed by the founding members of Architecture Curating Practice. They will be accompanied by two external members of the Brussels and international architecture scene. All the applicants will be notified of the jury's decision by e-mail on June 30 for a start of the residency on September 1.
